8.1 1400 Riddle Road (3 Blind Mice Area) – Park Designation & Management Plan

The Manager of Public Works provided the Committee with a presentation on 1400 Riddle Road (3 Blind Mice Area).

Brief discussions ensued regarding potential increases in liability to the City and increase in costs to PACA. A discussion also ensued regarding recommendation to rezone to Parks and Recreation and whether the City has the capacity to undertake this and invest the money. The Manager of Public Works clarified that the management plan would specify policies for users to follow and that City staff would not be responsible for providing anything in the hills.

Councillor Regehr entered the meeting at 2:22 p.m.

Dear Parks and Recreation Advisory Committee Membership:

The Penticton and Ellis Creek Restoration Select Committee (PECRSC) is currently working with Stantec consulting towards the development of an Ellis Creek masterplan. Past land use practices have heavily confined Ellis Creek into an unnatural, straightened channel, which has led to significant erosion and deposition issues within the stream channel within city limits. The masterplan aims to better appreciate Ellis Creek as a city asset overall and specifically improve planning and mitigation of flood risks, as well as better protect fish, wildlife and cultural values into the future. Some of the adjacent land to Ellis Creek is designated park land, and therefore successful planning for the future of Ellis Creek must integrate with any plans for that park land. Therefore, the Penticton and Ellis Creek Restoration Select Committee (PECRSC) has requested council approval to add a member of the Parks and Recreation Advisory Committee (PRAC) as a voting member to PECRSC. Council has approved the request, and as chair of PECRSC, I request that the PRAC solicit a volunteer from the committee membership who would be excited to join our committee and provide an important linkage in communication between the two committees to ensure the objectives of both committees are achieved through the Ellis Creek masterplan process.

# 2018 - 2020 Terms of Reference Penticton and Ellis Creek Restoration Select Committee

- 1. The Committee shall consist of **TEN** (10) voting members appointed by City Council for a term ending December 31, 2020 or at another date approved by Council. Preference will be given for:
  - One (1) representative and one (1) alternate of the Okanagan Nation Alliance
  - One (1) representative of the Penticton Indian Band
  - One (1) representative of the Fresh Water Fisheries Society of BC
  - One (1) representative and one (1) alternate of the Penticton Fly Fishers' Association
  - One (1) representative of the South Okanagan Conservation Program
  - One (1) downtown residential owner
  - One (1) downtown business owner
  - One (1) Penticton Industrial Development Association
  - One (1) member of the community based upon their interest in the Penticton Creek restoration
  - One (1) member of the Parks and Recreation Advisory Committee
- 2. The Committee shall consist of **TWO** (2) non-voting members:
  - One(1) representative and one (1) alternate of the Ministry of Forests, Lands and Natural Resource Operations: Fish and Wildlife Division
  - One (1) Representative and one (1) alternate of the Ministry of Forests, Lands and Natural Resource Operations: Water Stewardship Division
- 3. The Committee Members shall appoint a Chair and Vice-Chair each year.
- 4. Council shall appoint one (1) non-voting Council Representatives to the Committee annually.
- 5. Role of Council Representative:
  - Non-Voting Member
  - Liaison to City Council
- 6. A majority of appointed voting members shall constitute a quorum.

- 7. The General Manager of Infrastructure and City Engineer or designates, shall attend committee meetings to provide operational and professional engineering support to the Committee.
- 8. The Corporate Administration Department shall arrange for secretarial services to the Committee.
- 9. The Committee shall meet quarterly, or as required when a new piece of business is referred to the Committee requiring immediate action.
- 10. The Committee's mandate is to make recommendations to the Council on all matters referred to the Committee, including:
  - The technical matters related to the restoration and redesign of the Penticton Creek and Ellis creek;
  - The principles and design parameters of redesign and restoration, including the recognition of what impacts may occur on adjacent commercial and residential properties;
  - Land use issues within the Penticton and Ellis Creek riparian area;
  - Technical input an assistance with framing content related to Request for Proposals and expressions of Interest;
  - Public engagement strategies related to the restoration of Penticton and Ellis Creek; and
  - Development and recommendations on funding alternatives and fund raising.

#### 11. Disqualification from Office

If an advisory Task Force member is continuously absent from Task Force meetings for a period of three (3) consecutive regularly scheduled meetings, unless the absence is because of illness or with the leave of the Task Force members, Council may choose to replace the member. The person who held the office is disqualified from holding office on any advisory committee of the City of Penticton for a period of one year.

#### 12. Closed Meeting

Should a Closed meeting be held by the Committee, members must keep in confidence, any information considered in any part of said meeting until such time as the information is released to the public as lawfully authorized or required. Should the municipality suffer loss or damage due to contravention of confidentiality, the municipality may recover damages from the person(s) for the loss or damage.

- Closed Meeting no meeting or part thereof shall be closed to the public except in accordance with Section 90 of the Community Charter.
- 13. The Mayor will sign all correspondence initiated by the Committee on behalf of the City of Penticton.
- 14. For certainty, the rules and procedures of Council Procedure Bylaw No. 2018-35 and all amendments thereto shall be observed as far as may be applicable.



Major repairs needed to Skaha Marina's docks

Penticton city council isn't crazy about the spending more than \$1.7 million to replace the docks at Skaha Marina.

The city-owned facility's decrepit condition was brought before council Tuesday during the first day of 2018 budget talks.

"At this point I have zero comfort level in throwing \$1.7 million of the taxpayers money at Skaha Marina," Coun. Max Picton said "We need to have a fully comprehensive plan on what's going down there before we even consider spending that kind of money."

With the city's <u>cancellation</u> of its long-term lease with the Trio Marine Group, the responsibility for repairs and maintenance is falling to the public.

City staff suggested spending \$1.7 million over the next two years to replace the docks and \$150K to renovate the boat house. They also offered options that would see the docks completely removed, or a "pause" to gather more input from the public.

"The docks are not in great shape," said facilities manager Bregje Kozak, adding Trio had to conduct "a bunch" of band-aid repairs before they were able to open the marina this year.

Suggestions around the council table were made to send the matter to committee and to consult with the RDOS and Penticton Indian Band about their plans for the lake. Nobody spoke in favour and spending the money immediately.

"I personally think we need two marinas, because we are such a special city between two lakes. But we need to listen to what the people of Penticton want," Coun. Helena Konanz said, mulling that some residents apparently don't see the value in a marina on Skaha Lake.

City manager Peter Weeber reminded council that the clock is ticking, with the current Trio agreement set to run out at the end of 2018.

"So whatever plan we put in place would have to be implemented in 2019," he said "There could be a period where we would have to close the facility for a short period of time, because we are not in the business of running marinas."

City staff had earmarked \$700,000 for the project in the 2018 budget, but were directed by council to determine how much of that they would need to carry out public outreach.

Weeber said once council makes a final decision on the budget Thursday, city staff will get moving as quickly as possible on public consultation to prevent the marina from being mothballed in 2019.

#### THE PEOPLE'S CONCEPT

The concept you see is three years of studying all areas of a puzzle related to Skaha Lake Marina, Riparian, Dragon Boat, PIB, City, RDOS and Tickleberry Concession. Both parks groups and as many meetings as necessary to keep everybody informed and also for us to receive information.

In 2017, we were all aware that Trio was going to be out of the park at the end of the year. It seems most thought of this as the end but for some of us it was the beginning. I had already talked to Zoe Kirk, the conversation relating to mussels. During this time, she advised me to talk to Norman Johnson, Biologist at the Fish Hatchery. This was the first of many visits. A huge asset to our community. The information I received from Norman encouraged me to take his advice and investigate the Columbia River Treaty and its impact on the salmon. This system was about preventing flooding and using dams for power which turned out to be very successful. The Bonneville Power Authority's annual income is \$3.5 billion but as far as the environment, the dams removed the opportunity for the salt water fish which need fresh water to spawn. This was a problem from the Pacific Ocean as far inland as the Snake River entering the Columbia at Umitilla. This was eventually recognized as food missing from the Pacific Ocean which feeds Neptunes critters, plus the Aboriginal people. This has now been reversed to the point that we have sockeye salmon and the ability to fish for them in Skaha Lake, an important addition for our tourist industry.

This new knowledge compelled me to ask and receive for the 2017 Fisheries Act and the Aquatic Invasive Species Regulations. These were supplied by our MP Mr. Cannings from the Federal Library. The Fisheries Act constantly mentioned the importance of the habitat relating to the fish and the importance to the Aboriginal people.

We have had many meetings with James Pepper, the environmental representative from the PIB. He was excited to see three major pieces of design in the plan. One was that there would be no more moorage areas needed than the 94, a boat wash and the riparian area return to green, plus 150-foot ramp to divide the power boats from the paddlers and rowers. One hundred and fifty feet would be day moorage on one side and three dragon boats could be loaded on the north side at the same time. The beach area from the ramps to the boat house would be left for the paddlers and rowers. This has support from Randy Galagher and Don Mulhall. We have been very fortunate to have Randy and his family, Don and Launa, and Kelsey owner of Tickleberry, as custodians of the five hundred feet of waterfront. Randy's family has changed this area that looked industrial to one of welcoming and friendship. Don and Launa have twenty years of great organization and advertising of our City. Kelsey, a gem entrepreneur, willing to contribute to enhance the two areas of boat house and concession.

We must do what we can to make them all successful.

One, to assist Randy and his family to upgrade the docking if they feel it is necessary. Don and Launa deserve new accommodation as the one they are presently in is an eyesore and does not have the room to accommodate the increased enthusiasm. And maybe we should look at the serving area of the concession stand, faces into the sun on the hottest time of the day.

Restoring the Riparian area is also a high priority, stated by the South Okanagan Similkameen Conservation Program and Andrew Appleton, who is the Provincial Riparian Area Regulation and Coordinator, Ministry of Forests and Lands. This area is also very important that the promenade should continue in a park setting all the way to the boat ramps at the marina. This will also attract more people to the coffee shop at the marina.

Getting back to the Council meeting of November 2017, we have taken the time, done the research and also spent time to inform those mentioned in the Council meeting plus many more. At the same meeting the comments about money \$1.7 million, \$700 thousand and \$1,500. We have looked at three different dock systems - CanDock, DockKits, Trimark. The choice of docks is not altogether about money. It is about the system that satisfies the persons maintaining the docks.

I've priced out a new boat house - concrete block, metal roof, steel doors, sitting on a concrete slab - a maintenance free building.

Riparian - removal of some, not all, of the asphalt and replanting.

A boat wash is not practical because of a highwater table of ground water. A perk test would confirm this. One efficient answer would be a trained dog to check for mussels, owned by somebody, possibly at the marina. If mussels are found, apparently, the procedure is the boat and vehicle would be impounded until inspected by authorized persons who are available in Penticton.

Using the word "we" is the respect we must give to all who have participated in what you see and read.

I have tried to keep this as brief as possible and I want to thank the reader for the time they have taken to assess the information and plan.

Re: Skaha Lake Park Vision and Master Plan

I write to offer my enthusiastic support for the leadership shown by Peter Osborne in approaching a vison and plans for Skaha Lake Park.

Penticton's overarching PRMP was triggered by historic controversy over the future of this park. The Skaha Lake Park conflict was a painful experience for our community, and the ensuing PRMP process was a laborious and often partisan challenge that, in the end, produced a sound roadmap for the future of our parks. Our next step and a top priority now must be the development of a park-specific masterplan for the unique place and space known as Skaha Lake Park.

As we move forward, it is essential that we learn from our recent experience. And chief among the lessons to be learned is that specific plans for any park must be preceded by and subservient to a vison that articulates our values, prioritizes needs, identifies opportunities and pursues long-term outcomes.

Peter's proposal shows that he understands this. He clearly values the health and wellbeing of both our people and our ecosystems and he recognizes the unique opportunities that Skaha Lake Park and its waterfront present to pursuing these values. He prioritizes the need to encourage healthy physical activity through non-motorized water sports, and he sees the great opportunity this Lake presents to promote that by building on the existing and highly successful Dragon Boat program. He understands the important role this lake plays in the salmonid ecosystem and the need to protect the investment of the Okanagan Nation Alliance in its restoration.


But Peter also accepts the role Skaha Lake plays in supporting motorized watercraft through the existing marina, and he supports a planning process that would enable regulated coexistence of motorized and non-motorized recreational use of the lake and the waterfront land while prioritizing health and environmental interests. His thinking is clearly aimed at achieving long-term human health and environmental outcomes.

To conclude, I commend Peter's forward thinking, his aim to improve the health of our people and our environment, and his appreciation of the unique role that Skaha Lake, the park and its waterfront land can play in achieving these aims now and for the future.

It is the role of the Parks and Recreation Advisory Committee to advise Council on a master plan for Skaha Lake Park. This should be a high priority. I urge the Committee to embrace the values and the approach proposed by Peter to define a clear vision for the Park in relation to the lake as a prerequisite to identifying specific park-use plans. This process should include ample opportunity for public input.
