Please read carefully BEFORE you sign

*** YOU MUST ENSURE PEDESTRIAN SAFETY DURING THIS CLOSURE ***

- The work area does not occupy more than one half the width of the sidewalk abutting the premise or leave less than 4.9 ft./1.5 m. of clear unobstructed sidewalk for pedestrian use. If this condition is not met, the sidewalk **must be closed and barricaded** and pedestrians redirected to the nearest crosswalk.
- It will be your responsibility to properly barricade the area and provide signage. Signage must be posted at corners to advise pedestrians of the sidewalk closure. If you require barricades for your project, arrangements can be made with John Fenske at the City Yards Office at 250-490-2542.
- Hoarding may be required to ensure public safety.
- It will be your responsibility to ensure that you meet the standards acceptable to WorkSafeBC - www.worksafebc.com
- For hoses crossing the sidewalk, scaffolding should be placed in accordance with standard safety practices allowing hoses to pass over the sidewalk. You are responsible for ensuring pedestrian safety during installation and removal of scaffolding.

LIABILITY INSURANCE

YOU MUST PROVIDE proof of Comprehensive General Liability Insurance coverage for the minimum amount of **\$2,000,000.00**, with **The City of Penticton** named as an **"additional insured"**.

***IF ANY OF THE ABOVE TERMS & CONDITIONS ARE NOT ADHERED TO,
THIS PERMIT WILL BE IMMEDIATELY REVOKED.***
