4.1 Outdoor Rink – Activation Planning

THAT the Accessibility Committee recommend that the draft Urban Deer Management Strategy is referred to the Accessibility Committee.

July 8, 2026 is the last scheduled regular meeting.

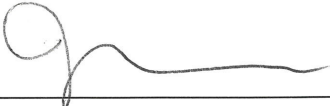
6. **Adjournment**
