Subject & Proposal

Development Variance Permit PL2024-9799

The applicant is proposing to construct an 18m² addition to the existing single-family dwelling at the rear of the building to provide an additional bathroom, mudroom and expand the second bedroom.



As such, the applicant has requested a variance to

Section 10.2.2.7 of Zoning Bylaw 2024-22 to reduce the interior side yard setback from 1.5m to 0.6m on the east side and 1.1m on the west side so that the addition will follow the setbacks of the existing building.
