Subject & Proposal

Zoning Amendment Bylaw 2024-38

The applicant is proposing to convert the existing building into a restaurant (with 3 additions to the structure) and convert the existing detached accessory building into a bakery (with 1 addition to the structure).



In order to facilitate the proposed restaurant/bakery development, the applicants have applied to add the following site specific provisions to the C1-Commercial Transition Zone for 689 Winnipeg Street:

- Allow bakery as a permitted use
- Restaurant shall not exceed a maximum gross floor area of 650m2
- Minimum 4 vehicle parking stalls to be provided
- The rear yard setback for an accessory structure shall be 0.0m
