# Subject & Proposal Zoning Amendment Bylaw 2025-04

The applicant is proposing to allow strata unit owners the ability to operate short-term rentals through a 'strata hotel' arrangement at 270 Riverside Dr. (271 Wylie St.).

This use would fall under the 'resort residential' use in the City's zoning bylaw. Resort residential is not currently a permitted use in the CD2 – Comprehensive Development (270 Riverside Drive) Zone and a zoning bylaw

amendment has been requested to include the use in the list of permitted uses.
