Subject & Proposal:

Temporary Use Permit PL2025-9963

The applicant has applied for a Temporary Use Permit to allow for the use of temporary off-site construction storage, a construction office trailer and vehicle parking at 582 and 598 Main St. The purpose of this application is to allow the applicant to use this site for construction storage purposes while they are building on a nearby site in the downtown area. The subject properties are zoned C5 – Urban Centre Commercial, which does not permit the use of construction storage and vehicle parking.

The Temporary Use Permit expires three years from the permit issue date.
