### Subject & Proposal:

**Temporary Use Permit PL2025-10094**

The applicant is proposing to continue to operate their parkour business inside one of the units at 647 Okanagan Ave. E. Currently, this use is not permitted within the M1 – General Industrial zone and therefore requires a temporary use permit to allow the 'indoor amusement, entertainment and recreation' use.



If approved, the temporary use permit expires three years from the permit issue date and Council has an option to renew the permit for an additional period of up to 3 years
