Zoning Bylaw Amendment

As part of the Provincial Government's Housing Action Plan and new legislation (s. 464 of the Local Government Act, effective November 30, 2023), the City is prohibited from holding a Public Hearing for Zoning Amendment Bylaws that facilitate residential development and are consistent with the Official Community Plan. As such, there is no opportunity to speak to Council in person.

Proposal:

The properties are zoned RM3 – Medium Density Multiple Housing. The RM3 zone

includes a site-specific provision for the properties that apartment use is not permitted. The applicant has requested that this site-specific regulation be removed.

Removing the site-specific provision is consistent with the Official Community Plan land use designation of High Density Residential which permits apartment buildings up to 6 storeys.
