Subject & Proposal:

Temporary Use Permit PL2025-10079

This application proposes to add "emergency shelter and homelessness services" as a permitted use on the identified portion of the subject properties (Figure 1). The permit would enable the development of temporary transitional housing on the site for 3 years, through the provincial HEART and HEARTH program.

If approved, the temporary use permit expires three years from the permit issue date and Council has an option to renew the permit for an additional period of up to 3 years.

Council Consideration:

Council will consider the Temporary Use Permit at its Regular Council Meeting scheduled for 1:00 p.m., Tuesday, November 4, 2025 in Council Chambers, Penticton City Hall, 171 Main St.
