Subject & Proposal

Official Community Plan Amendment Bylaw 2025-31

Zoning Amendment Bylaw 2025-32

Staff are proposing amendments to Official Community Plan Bylaw No. 2019-08 and Zoning Bylaw No. 2024-22 to align with provincial requirements under *Bill 44 – Housing Statutes (Residential Development) Amendment Act, 2023*.

The Province now requires local governments to take a more pro-active approach to planning for housing. This means the City must ensure its policies and zones address housing needs over the next 20 years.

In addition, recent zoning changes that allow small-scale multi-unit housing and create transit-oriented areas must now be consistent with the City's long-term planning vision in the Official Community Plan. To address this provincial requirement, staff are proposing a combination of zoning and OCP changes to affected properties.

The Province has set a deadline of December 31, 2025, to complete these requirements.
