BYLAW NO. 2012-5021

A BYLAW TO AUTHORIZE THE USE OF THE
MUNICIPAL TICKETING INFORMATION SYSTEM

WHEREAS Section 264(1)(a) of the *Community Charter* empowers the City of Penticton, by bylaw, to designate those bylaws for which municipal ticket information may be used as a means of bylaw enforcement;

AND WHEREAS Section 264(1)(c) of the *Community Charter* empowers the Council to, by bylaw, authorize the use of any word or expression on a municipal ticket information to designate an offence against a bylaw;

AND WHEREAS Section 265(1) of the *Community Charter* empowers the Council to, by bylaw, set fine amounts;

AND WHEREAS the Council deems it expedient to authorize the use of municipal ticket information for the enforcement of certain bylaws, to authorize the use of certain words or expressions to designate certain bylaw offences and to set certain fine amounts.

NOW, THEREFORE, the Council of the City of Penticton in open meeting assembled enacts as follows:

1. CITATION:

This Bylaw may be cited as the "City of Penticton Ticket Information Bylaw No. 2012-5021".

2. ADMINISTRATION

2.1 The bylaws listed in Column 1 of Schedule A to this bylaw, as amended from time to time, may be enforced by means of a ticket in the form prescribed for the purpose of Section 264 (1)(a) of the *Community Charter*.

2.2 The persons appointed to the job positions or titles listed in Column 2 of Schedule A to this Bylaw are designated as bylaw enforcement officers pursuant to Section 264 (1)(b) of the *Community Charter* for the purposes of enforcing the bylaws listed in Column 1 of Schedule A opposite the respective job positions.

2.3 The words or expressions set forth in Column 1 of Schedule B, as amended from time to time, designate the offence committed under the bylaw section number appearing in Column 2 opposite the respective words or expressions.

2.4 The amounts appearing in Column 3 of Schedules B1 – B19 to this Bylaw, as amended from time to time, are the fines set pursuant to Section 264 and 265 of the *Community Charter* for the corresponding offences designated in Column 1.

3. REPEAL

3.1 Bylaw #2010-64 and all amendments thereto are rescinded upon the adoption hereof.
