## 8.1 <u>Development Variance Permit PL2016-7614</u>

# 8.4 <u>Vacant Building Registration Permit Renewal</u>

Re: 555 Wade Ave. E

#### 155/2016 It was MOVED and SECONDED

THAT Council deny the request to renew the Vacant Building Registration Permit for 555 Wade Ave East, Lot 1, Plan 7142;

AND THAT Council declare, pursuant to the "Good Neighbour Bylaw No. 2012-5030", that the building alone on the Property is a hazard to the community within the meaning of the Good Neighbour Bylaw;

AND THAT Council declare, pursuant to Division 12 of Part 3 of the *Community Charter* that the Property as a whole (building, retaining wall, etc.) is a nuisance and/or in a hazardous condition and requires remedial actions to be completed by May 9, 2016;

AND THAT Council order the owners and any other owner or occupant of the Property with notice of this Order to remove the building, obtain an engineer's report on the retaining wall and remediate it accordingly, all in accordance with Division 12 — Remedial Action Requirements of the *Community Charter* as well as the concurrently running 30 days' notice requirement set out in the "Good Neighbour Bylaw No. 2012-5030" with respect to the building demolition;

AND THAT Council authorize staff to commence a proceeding in the British Columbia Supreme Court after the time for the owners' compliance has expired, to enforce the "Good Neighbour Bylaw No. 2012-5030" and the remedial action Orders by way of civil injunction.
